**RESOLUTION NO. 2010 - 11**

**A RESOLUTION APPROVING THE FORM OF NOTICE TO PROPERTY OWNERS CONCERNING ANY TREE REMOVAL EXCEEDING SIX (6) INCHES IN DIAMETER WITHIN A RIGHT-OF-WAY OF ANY TOWNSHIP ROAD OR HIGHWAY WITHIN WEST PENNSBORO TOWNSHIP, CUMBERLAND COUNTY, PENNSYLVANIA.**

**WHEREAS**, the Board of Supervisors of West Pennsboro Township, Cumberland County, Pennsylvania, in accordance with Section 2325 of the Pennsylvania Second Class Township Code, is required to approve the form of notice to property owners when shrubs and trees (trees in excess of six inches) the board of supervisors or its agents finds to constitute a hazardous or dangerous condition to the use of the highway or those which impair the use or maintenance of the public road or street.


**RESOLVE**, and it is hereby resolved, this 23<sup>rd</sup> day of August 2010, the West Pennsboro Township Board of Supervisors hereby authorizes the use of the form of written notice attached hereto (exhibit #1) and directs that the mailing of the notice shall be by certified mail with return receipt and, in addition, when possible, the notice shall be personally delivered to the owners by Township Personnel no less than ten (10) days prior to the commencement of the tree removal. This Resolution shall remain in effect unless and until repealed or amended by the Board of Supervisors of West Pennsboro Township in accordance with applicable law.


CERTIFICATE
