RESOLUTION NO. # 2011-02

A RESOLUTION AMENDING THE SEWER SYSTEM RATES, RULES & REGULATIONS TO PROVIDE FOR A MINIMUM SERVICE RENTAL

WHEREAS, the Authority deems it necessary to amend the Sewer System Rates, Rules & Regulations to provide for a minimum service rental to be charged where service is discontinued but there remains the need and responsibility of the Authority to maintain the sewer system to be available for such properties. This charge is required to help offset the fixed costs of maintaining the Authority sewer system in a functioning status during the time period that the subject property is disconnected from the Authority sewer system.

NOW, THEREFORE, BE IT RESOLVED AND ADOPTED by the Board of Directors of the West Pennsboro Township Municipal Authority, as follows:

1. Section 8.4 is amended to add the following paragraph and language:

B. If the service at a property which is utilizing five (5) EDU's or more is physically removed for a period of three (3) months or more(whether continuous or otherwise) during a twelve (12) month period and the Owner wishes to retain wastewater capacity, the Owner shall be required to pay a monthly Minimum Service Rental. This Minimum Service Rental will be calculated using only the fixed costs to the Authority and shall be in accordance with the Authority Schedule of Fees and Charges. Billing will begin at the end of the first month of disconnection. If the Owner is non-residential and billings are based on flow, then the billing relating to EDU's for the Minimum Sewer Rental shall be based on the previous twelve (12) month average flow divided by 250 gpd/EDU. This requirement for a Minimum Service Rental shall be subject to separate agreements that may exist between the Authority and the Owner. This Minimum Service Rental shall become effective upon the date of adoption of this Resolution.


The remaining paragraphs of Section 8.4 shall be re-lettered, "B through E" shall become "C through F" respectively.

2. This amendment shall become effective immediately.
