

**RESOLUTION 2011-06**

**A RESOLUTION OF THE WEST PENNSBORO TOWNSHIP BOARD OF SUPERVISORS, CUMBERLAND COUNTY, PENNSYLVANIA AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION TO THE PENNSYLVANIA DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT FOR A SHARED MUNICIPAL SERVICES GRANT.**

**WHEREAS**, the Township of West Pennsboro, the Borough of Newville, the Newville Borough Water and Sewer Authority and the Big Spring School District wish to enter into an Intergovernmental Cooperation Agreement whereby the municipalities and the Big Spring School District shall cooperatively develop a master plan for the Big Spring area; and

**WHEREAS**, the Township of West Pennsboro, the Borough of Newville, the Borough Water and Sewer Authority and the Big Spring School District have each allocated \$3,125 in order to provide \$12,500 in municipal funding for the project; and

**WHEREAS**, the Cumberland County Board of Commissioners through the Redevelopment Authority of the County of Cumberland shall be requested to allocate \$10,000 through the Community Development Block Grant Program; and

**WHEREAS**, the municipalities and Big Spring School District intend to submit an application for funding assistance to the Pennsylvania Department of Community and Economic Development for a Shared Municipal Services Grant in the amount of \$22,500.

**NOW, THEREFORE, BE IT RESOLVED** and it is hereby adopted by the West Pennsboro Township Board of Supervisors that the local matching funds in the amount of \$3,125 have been approved as part of the 2011 West Pennsboro Township General Fund Budget.


**BE IT FURTHER RESOLVED** that the proper officials of West Pennsboro Township shall hereby be authorized to submit an application to the Pennsylvania Department of Community and Economic Development for a Shared Municipal Services Grant in the amount of \$22,500.
