VOLUNTEER FIRE COMPANY**

**WHEREAS**, the Township of West Pennsboro believes it is in the interest of public health, safety and welfare to have new and up-to-date fire equipment to serve the best interests of the citizens of West Pennsboro Township;


**WHEREAS**, the Township of West Pennsboro desires to seek financing for the acquisition of a new fire truck in part through the preparation and dissemination of an RFP to seek proposals for the necessary financing; and

**WHEREAS**, the Supervisors of West Pennsboro Township desire to authorize the Township Manager and his staff to perform all administrative functions necessary to assist in obtaining the necessary financing, with the Supervisors of West Pennsboro to be responsible to make the final decision as to the successful lending institution.


