RESOLUTION NO. 2012-03

A Resolution of West Pennsboro Township (the "Municipality"), authorizing the adoption of a revised fee schedule, originally adopted by Resolution #2008-09 on October 27, 2008, for professional fees to be charged by West Pennsboro Township professional advisors for the review and inspection of submissions generated by the West Pennsboro Township Subdivision and Land Development Ordinance (1998-01) and the West Pennsboro Township Zoning Ordinance (2011-04).

WHEREAS, West Pennsboro Township is required to engage legal and engineering services in conjunction with the West Pennsboro Township Subdivision and Land Development Ordinance and the West Pennsboro Township Zoning Ordinance, and

WHEREAS, West Pennsboro Township is authorized by law to charge the aforesaid fees for such services to the applicant.

Now therefore, be it resolved that the Board of Supervisors of West Pennsboro Township does hereby adopt the fee schedule attached hereto and marked as Exhibit "A", pertaining to legal fees, and Exhibit "B", pertaining to engineering fees.




CERTIFICATE
